# Architectural Design in Historical Context -

## Design studio

- **Introduction:** objectives, content, scope, process, assessment methods, etc,
- **Theoretical background** of architectural heritage preservation. Main provisions of International charters, guidelines, recommendations and other important theoretical sources (books, articles, etc) for student self-reading

## **Initial insights and attitudes:**

- Sustainable development practices and historic preservation efforts are imbued with contradictions, overlappings and shortcomings.
- Adaptive reuse is a tool for the sustainable preservation of existing building stock that bridges the approaches of development and preservation and more appropriately addresses the values of time, energy, place and community with respect to the built environment.
- Destruction of both material and abstract qualities can be circumvented by actively engaging a site, landscape or context through revealing and crossbreeding complex patterns, traces and perspectives.

## **Objectives of the course:**

to provide the **understanding of the contextual approach** while designing in historical environment

to give the competence **to interpret the data of historic research** to highlight architectural value of the city

to provide the competence **to generate conception** (solutions) that maintain and strengthen the identity of the place

P1	Learning how to collect the historic data of the city (or area); looking for the different sources and for varied aspects to incorporate.
P2	Learning how to make research,: to systemize the collected data, to select and group the data (bibliographic. cartographic, iconographic and other recorded sources); to synthetize the data and to highlight the essential historical periods.
P3	Visiting the objects, and making investigation <i>in situ</i> (observing, drawing, photo fixation, using other recording measures). Identifying the actual situation of the place.
P4	Learning how to interpret the historic context and to articulate values and definition of the significance. Draw the informed opinion about the building today.
P5	Drafting the argumentation for intervention. Study of analogous; creating the conception of design (possible options) that can strengthen the identity of place.
P6	Learning how to generate possible scenarios for intervention (solutions based on the results of historic research) that can maintain and strengthen the identity of the place. Elaboration of the best concept of design
P7	Elaboration of the best concept of design
